**Water supply status update by exception (i.e. areas affected due to supply constraint and not service interruption from occasional pipe burst)**

The water supply across the City of Johannesburg is normal, with reservoir levels across the city in a satisfactory position.

Level-2 water restrictions according to section 44 (3) of the Water Services Bylaw states that all consumers are forthwith compelled:

- b) Not to fill their swimming pools with municipal water; and
- c) Not to use hosepipes to wash their cars, paved areas, etc.
